

Identifying a Ponzi or Pyramid Scheme

Ponzi schemes and pyramid schemes sustain themselves by recruiting new investors, and both collapse without a constant influx.

Ponzi's use new investments to pay earlier backers, promising high returns and no legitimate business underpins them.

Pyramid schemes masquerade as viable MLM businesses but rely on recruitment fees over actual sales for income.

Both Ponzi Schemes and pyramid schemes are illegal.

- Recruitment in LiveGood is voluntary and most of the one-time affiliate fee is paid out as Affiliate Referral Bonus's with the remainder going towards the included back-office, affiliate websites, training, tracking, etc.
- 3. The LiveGood business model is such that it is possible to earn up to \$2047.50 without recruiting a single person, something that is unheard of in the networking industry. Some companies provide rewards for purchase volume as an instore credit. With LiveGood it's paid out on a small share of the memberships falling into the affiliate's matrix, even if not personally placed there.
- 4. There is no pressure or requirement to buy, to sell, or to recruit, and high-pressure sales tactics are banned according to LiveGood terms and conditions. In addition to no auto-ships or mandatory stocking, products have a 90-day empty bottle money back guarantee.
